### Report from the East Midlands National Pensioners Convention Annual General Meeting

I attended the East Midlands National Pensioners' Convention (EMNPC) Annual General Meeting at The Mechanics Institute in Nottingham on Wednesday 22<sup>nd</sup> March 2023. I had a real problem with my hearing on the day and my hearing aids decided not to work properly, so hearing everything, especially form behind was difficult. All since sorted out. There was no hearing loop. Should I attend further meetings I will ask for one. There were others with hearing aids there too.

We were welcomed by the secretary Clare Wilkins and the chair Michael McLoughlin. There were approximately19 who attended (not sure as most sat behind me) and 15 apologies. There were no matters arising from the AGM of 23<sup>rd</sup> March 2022. The Secretary's' and the Treasurers' reports were tabled.

Our guest speaker was Rosie MacGregor, the National Pensioners' Convention President. Rosie said she was pleased to be back at the EMNPC and felt very welcome. She spoke quite a lot about the NPC Pension Policies and working to amend the division between 'Those who have and those who have not'. She touched on the cost of energy and she also spoke regarding the 'Tripple Lock', which I am sure pensioners are very well acquainted with. She spoke about the 10% this year as opposed to costs, and also about the coffin that was brought to10 Downing Street. The problem of either heating or eating that some pensioners have to weigh up was also spoken about. She told us that there were 2 Million+ pensioners in poverty. The NPC are committed to fairness and are asking the government to raise the State Pension to equal work pay. She spoke about pension age and the fact that the pension age keeps going up that some of todays' teenagers were 'likely to die before reaching pension age'. The NPC are campaigning for the government to have 'A Commissioner For Old People'. Some pensioners who have had their homes broken into have been put on Pre Payment-Meters. On a side, I'm not too sure why Rosie had spoken about this, other than to make sure pensioners who have this happen do not have meters broken into to take cash. Rosie spoke at length about colder persons and there should be proper energy for all. There is to be a 'Digital Working Party' set up. She spoke about Digital Inclusion and Access to Technology for pensioners. Also, about Dignity In Retirement.

The chair thanked Rosie an passed on a gift.

There was quite a discussion regarding the Older Persons Manifesto. Some people were suggesting that the NPC should lobby Age UK to get involved more. We were told that Age UK get a large payment from the government and might not want to 'rock the apple cart'. There was lots of discussion regarding peoples' personal pensions.

Following this the elections for the officers and committee members of the EMNPC were held and most of the sitting members, that wanted to continue, with 3 others were elected. The election of 4 members to attend the Special Delegate Conference were elected. Being new to the group I didn't feel it was right to put myself forward.

There were 3 motions passed to take to the conference, these were Basic State Pensions, Decline in Bus services, Support for Carers and also Energy Tariff.

There was no further business and the chair closed the AGM.

The Special Delegate Conference will be held on 26<sup>th</sup> June in Blackpool.

The date of the 2024 AGM is to be decided and may possibly be 20<sup>th</sup> March 2024.
